From the Editor!

The Ides of March! have come and gone and we are marching on further into 2012.

In this issue we are doing something new, as a way of sensitizing the whole Corporation on the inner working of each Dept we are doing an overview of the Legal department. Yes, apart from having a crop of well trained and very good looking lawyers we are also ensuring the Corporation is covered legally.

We start with the Litigation Unit headed by the debonair B.A Taribo in this edition and we invite all other departments to send us overviews of what they do. In the Q and A section we are also answering our first questions sent in by Mrs B.I Obeke please keep the questions coming.

Q What is a garnishee order nisi and qua liquidator in the context of January’s piece?

A A garnishee has been defined as a statutory proceeding whereby a person’s property, money or credit in possession or under control of or owing by another are applied to payment of former debt to a third person by a proper statutory process against debtor and garnishee. Now the first step in obtaining an order nisi by a judgment creditor is to file a motion exparte seeking for order nisi. A garnishee order nisi is only an interim (temporary) order and attaches immediately. The person on whom an order nisi is served is expected to attach or freeze transaction on the account in question. No fund is to be paid to the court until the order is made absolute (or final) otherwise, a good discharge is not obtained against the judgment – debtor. The order is directed to the garnishee attaching the debt claimed to be due from him to the judgment debtor. The service of the order on the garnishee and the judgment debtor is to

be effected at least 14 days before the hearing that is, the return date. The garnishee is to show cause why he should not pay the debt. The implication of the garnishee order nisi in relation to the issue under consideration is that the CBN as garnishee cannot debit the account of NDIC or the account of a defunct bank, since the order has yet been made absolute. This would amount to pre-empting the court and undermining the whole garnishee proceeding. The garnishee order nisi is tantamount to a notice to the CBN to show cause why it should not debit the account of the defunct bank in satisfaction of a judgment debt, and nothing more.

Qua is a latin term now used in philosophy which literally means “In general” or “As” or “In the capacity of”. In the context of this piece qua liquidator simply means in the capacity of the liquidator

LITIGATION UNIT OVERVIEW

The Litigation Unit (hereinafter, “the Unit”) of the Legal Department is vested with the primary responsibility of managing the Corporation’s cases in court. The Unit which is based in Abuja, Head Office of the Legal Department, is composed of eighteen (18) Legal Officers who are divided into 4 (four) teams. In addition to performing routine functions of monitoring cases and liaising with External Solicitors, each team is given special functions to discharge. Some of these functions include:

- Team 1:**
- Preparing the Schedule of Contingent Liabilities for External Auditors;
 - Preparing the Schedule of all pending litigations; and
 - Preparing the Schedule of high profile cases

Team 2:
Managing all litigation related to Microfinance Banks

- Team 3:**
- Preparing the monthly cause list for the unit;
 - Managing debt recovery matters; and
 - The collation of MCC updates

Team 4:

- Managing all Corporate Cases;
- Managing judgment enforcement matters; and
- Managing criminal cases

CASE MANAGEMENT

The Unit manages an aggregate of **126 (one hundred and twenty-six)** cases relating to deposit money banks. The cases in Courts in Abuja and the Northern part of the Country are monitored by the Unit while cases in Courts in the South are monitored by the Lagos office, and the Unit exercises ‘oversight’ functions for such cases.

An aggregate of **109 (one hundred and nine)** cases relating to failed Microfinance Banks are being managed by the Unit in Abuja. As at February 2012, the Corporation had obtained the court orders for the advertisement and publication of winding-up petition in respect of **59 (fifty-nine)** Microfinance Banks. Furthermore, winding-up orders were obtained for **14 (fourteen)** Microfinance Banks out of the fifty-eight.

The Unit manages debt recovery cases of the Corporation as liquidator of failed banks, assigned to External Solicitors for the purpose of recovery. As

monitored by the Lagos office, and the Unit exercises ‘oversight’ functions for such cases.

An aggregate of **109 (one hundred and nine)** cases relating to failed Microfinance Banks are being managed by the Unit in Abuja. As at February 2012, the Corporation had obtained the court orders for the advertisement and publication of winding-up petition in respect of **59 (fifty-nine)** Microfinance Banks. Furthermore, winding-up orders were obtained for **14 (fourteen)** Microfinance Banks out of the fifty-eight.

The Unit manages debt recovery cases of the Corporation as liquidator of failed banks, assigned to External Solicitors for the purpose of recovery. As of February 2012, there were **104 (one hundred and four)** high profile debt recovery cases pending in court filed against debtors of failed banks.

As at February 2012, there were a total of 9 (nine) corporate cases and 4 (four) criminal cases being monitored by the Unit, while exercising oversight functions for corporate and criminal cases monitored from Lagos and Enugu Offices of the Legal Department.

The unit also manages enforcement of judgments given in favor of the Corporation by various courts in Abuja and the Northern parts of the Country.

The unit produces a harmonized monthly cause list for all the legal officers in the unit. The cause list contains details of suits scheduled to come up in various courts within that month, the contact details of the solicitors handling the suits, the next adjourned date and the purpose for which the matter will be coming up before the court. This is to ensure that all legal officers are abreast with their cases and are able to liaise properly with the solicitors handling the cases for effective monitoring. In line with this duty, the unit maintains a litigation diary which is updated constantly after every court proceeding.

IMPLEMENTATION OF SECTION 40, NDIC ACT

Section 40 of the NDIC Act, 2006, empowers

Legal Officers in the employment of the Corporation to appear in court and represent the interests of the Corporation in any matter. (Please go to the next page for the schedule of cases)
